Sir,

I have submitted the RTI Application dtd. 2.5.2016, and the reply No. CIC/CPIO/RTI-Cell-Misc/2016/132559 dtd.13.5.2016 has been received.

The reply was unsatisfactory and RTI Act-2005, Appleal-1 dtd. 30.5.2016 was submitted, and the reply No. CIC/AA/A/2016/344 dtd. 22.8.2016 was received on 3.9.2016. Again the belated reply is unsatisfactory.

So it is humbly requested that the information sought may please be provided through RTI Act-2005, Appleal-2.

Abusing my RTI Application dtd. 22.11.2013 by the CPIO, Supreme Court of India and followed by the undue support of CIC in Appeal-2 (No.CIC/RM/A/2014/001481 dtd.2.3.2016) towards the CPIO was the reason for submitting the RTI Application dtd. 2.5.2016. <u>The CPIO, Supreme Court of India have never provided me a proper signed</u> <u>RTI reply except sending some belated Email messages with Lie, Wrong and Misleading</u> <u>Informations.</u> The CPIO was saved by the CIC during Appeal-2 without even imposing any fine, even though the information sought was available. That was an injustice.

I have submitted another RTI Application dtd. 17.3.2016 to the State Information Commission, Kerala and was forwarded to some other offices by RTI Section 6(3) and the reply No. K5/849/T/2016 dtd. 28.4.2016 was received from Regional Transport Office, Trivandrum on my Question No.10. <u>Thus proving my RTI Application dtd. 22.11.2013 was</u> very well covered under RTI Section 2(f).

Here again the reply for my Appleal-1 dtd. 30.5.2016 was delayed beyond the specified time limit, and also unsatisfactory. <u>If my RTI Application dtd. 22.11.2013 was not covered under RTI Section 2(f) and the CIC supported it, The reply of the CPIO, CIC on my RTI Application dtd. 2.5.2016 should also have been same.</u>
