Ref.1 was forwarded to the Asst. Commissioner of Police, Cybercity-Kazhakuttom for necessary action (No. 166/CPEmail/TC-18) by CP on 14.2.2018.

On 16.2.2018 at 10:01am I talked to ACP, Cybercity-Kazhakuttom on Ph.9497960113 and was promised to register case and my petition was forwarded to Thumba Police for action and phone call from Thumba Police Station was received at 10:15am, asking me to give statement in connection with registering the case against the Mike set owner.

Immediately I went to Thumba Police Station and my statement was taken to register FIR against the Mike set owner Sri. Viswanathan, Matha Sounds, Poundkadavu, Trivandrum-695021.

On 28.2.2018 at 5:04pm, I enquired to the SI Thumba on Ph.9497980025 about the FIR copy of the case. Unfortunately I was told that the case is Non-cognizable and not so serious so the FIR was not registered.

The case is serious and the loud-speakers were used between 10pm and 6am violating the Noise Pollution rules, violated 300 meters distance limit and violated decibel level too. Which can attract up to Rs.1 lakh fine and up to 5 years imprisonment or both as punishment according to the Noise Pollution (Regulation and Control) Rules, 2000 and U6-30380/2002.

I was continuously complaining about the violations to the Police, but the Police were reluctant in taking proper action in time, instead they asked the violator to reduce volume and were not maintained at all. Using the loud-speakers after 10pm till 12:30 was also reported to the Police.

If the case is Non-cognizable, the permission from the Hon. Court can be requested and achieved. The Case No.280/15 CC No.621/17 taken up in the JFMC-V Court was not as serious as this case but the permission was granted by the Hon. Court.

So it is humbly requested that, the FIR may be registered and the permission from the Hon. Court may be achieved for further action.
